Water Well Registration Form

Completion of this form satisfies well registration requirements under District Rule 5.1 and Texas Water Code Ch. 36, Subchapter D. The District's rules require the registration of ALL wells within the District. Additionally, the owner or operator of a registered well must re-register the well on a new registration form if the owner plans to change the type of use of the groundwater, increase the withdrawal rate, or substantially alter the size of the well or well pump. It is a violation of the District's rules for any person to drill a well or authorize the drilling of a well without the approved registration form filed with the District.
